**POLL RESULTS OF THE SPECIAL GENERAL MEETING
HELD ON 18 JULY 2013**

The Board announces that at the SGM held on 18 July 2013, the Ordinary Resolutions were duly passed by the Independent Shareholders by way of poll.

Reference is made to the notice of special general meeting of Regal Hotels International Holdings Limited (the "Company") dated 29 June 2013 (the "SGM Notice") and the circular of the Company dated 29 June 2013 (the "Circular"). Unless otherwise stated, capitalised terms used herein shall have the same meanings as those defined in the Circular.

At the SGM held on 18 July 2013, the proposed ordinary resolutions as set out in the SGM Notice (the "Ordinary Resolutions") were duly passed by the Independent Shareholders by way of poll. The Company's branch share registrar in Hong Kong, Computershare Hong Kong Investor Services Limited, was appointed as the scrutineer for the poll taking at the SGM. The poll results of the Ordinary Resolutions passed at the SGM are as follows:

As at the date of the SGM, the total number of issued Shares is 964,074,333 Shares. As stated in the Circular, Mr. LO Yuk Sui, Century City, Paliburg and their respective associates, in aggregate holding 521,870,161 Shares as at the date of the SGM, were required to, and did, abstain from voting on the Ordinary Resolutions at the SGM. Save as aforesaid, no other Shareholders were required to abstain

from voting on any of the Ordinary Resolutions. The total number of Shares entitling the Independent Shareholders to attend and vote for or against the Ordinary Resolutions at the SGM was 442,204,172 Shares. No Shareholders were entitled to attend but were required to abstain from voting in favour of any of the Ordinary Resolutions at the SGM.
