**Letter to new shareholders**

**– Election of Language and Means of Receipt of Corporate Communications**

In accordance with Rules 2.07A and 2.07B of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange"), we are writing to invite you to elect as to which language and/or means of receipt of Corporate Communications (*Note*) of Paliburg Holdings Limited ("Paliburg") to be despatched to the shareholders of Paliburg in the future.

If we do not receive the completed Reply Form by 27th May, 2010, we will send you the printed Chinese version of each future Corporate Communication if you are an individual shareholder with a Chinese name and having an address in Hong Kong so registered in Paliburg's Register of Members; or if you are an individual shareholder with an English name only and/or residing overseas or a corporate shareholder so registered, we will send you the printed English version.

If you choose to access Corporate Communications using electronic means through Paliburg's website, we will send you an email notification of the publication of the relevant documents on Paliburg's website on the same day that each Corporate Communication is sent to the shareholders of Paliburg. For such purpose, please be reminded to provide us with your email address.

You are entitled at any time by reasonable notice in writing or via email: [paliburg-ecom@hk.tricorglobal.com](mailto:paliburg-ecom@hk.tricorglobal.com) to Paliburg's Hong Kong Branch Registrar to change your choice of language and/or means of receipt of Corporate Communications. If you have chosen electronic means and, for any reason, have any difficulty in receiving or gaining access to the relevant documents, Paliburg or its Hong Kong Branch Registrar will promptly upon request send the printed form of the same to you free of charge.

Both the printed English and Chinese versions of Corporate Communications of Paliburg will be available from Paliburg or its Hong Kong Branch Registrar on request, and both versions will also be available in assessable format on the Stock Exchange's website at [www.hkexnews.hk](http://www.hkexnews.hk) and Paliburg's website.
